Clean electricity accounted for around 80% of new capacity additions to the world's electricity system in 2023, and electric vehicles for around one out of five cars sold globally.



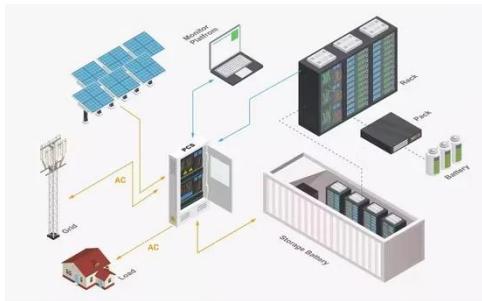
