


Chilean microgrid electricity bill



Overview

Chile's lower house approved a bill to expand electricity subsidies for lower-income families after stripping out a measure that would have raised part of the funds required by curbing profits in a segment of the renewable energy industry. The probability of passage is unclear, but should the bill become law, it could reduce revenues and debt.
