All existing and new eWaste category bidders are requested to note that a new e-Waste (V2) category is now available for all relevant auctions;. 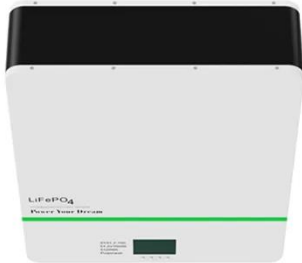

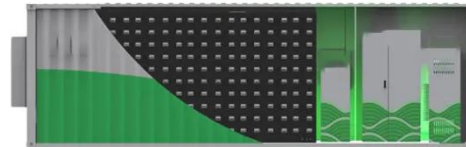

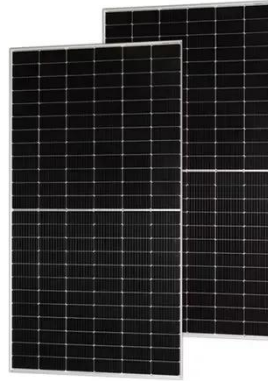
