Overview

With the passage of the Trump administration's "One Big Beautiful Bill," residential solar power systems need to be installed and likely. After Decem, it will be gone completely. 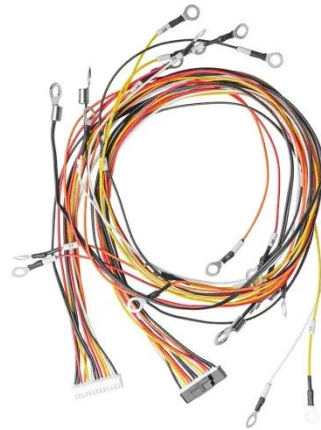
